A certified check or bank draft drawn on a solvent bank in the State of Michigan payable without condition to the City of Albion or a satisfactory bid bond executed by the bidder and a surety company, in an amount equal to 5 percent of the bid shall be submitted with each bid.

No bids may be withdrawn after the scheduled closing time for receipt of bids for a period of sixty (60) days to allow the review of proposals and to allow completion of necessary financial arrangements.

The successful bidder will be required to furnish a satisfactory Performance Bond and Payment Bond in the amount of 100 percent of the Contract price. Bond forms are included in the Contract Documents.

This project is being funded in part through a grant from the Michigan Economic Development Corporation, Community Development Infrastructure Capacity Enhancement Grant Program. The CONTRACTOR shall comply with all requirements of this granting agency.
